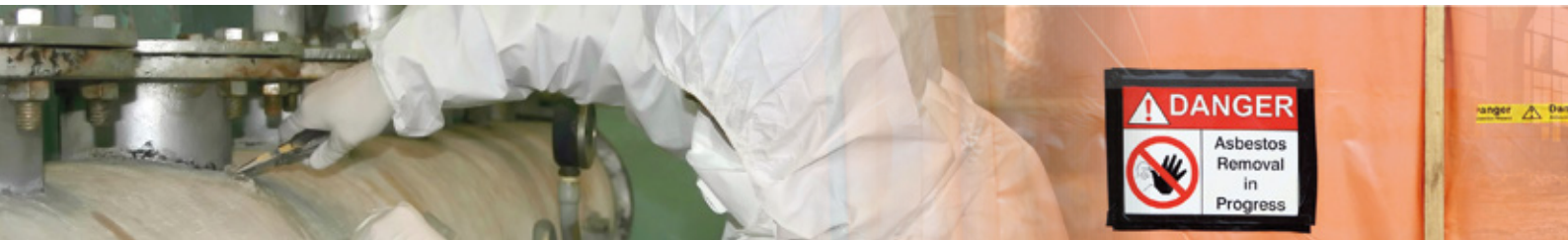

Asbestos removal is one of the most highly legislated services in the UK (The Control of Asbestos Regulations 2012 came into force on 6 April 2012, updating previous asbestos regulations) and an extremely specialised and skilled occupation.

Asbestos removal should be carried out only by companies, which are licensed and fully qualified to do so. There are penalties if you fail to appoint an organisation without the compulsory credentials.
